NOTICE IS HEREBY GIVEN that a casual vacancy is deemed to have occurred in the office of Councillor for the **Poulton with Fearnhead Parish Council** following the resignation of William David Gibson.

Rule 5 of the Local Elections (Parishes and Communities) (England and Wales) Rules 2006, provides that on a casual vacancy occurring in the office of **Parish** councillor, an election to fill the vacancy shall be held if within fourteen days* after the date of this notice (i.e. **no later than 9 August 2022**) has been given in accordance with section 87(2) of the Local Government Act 1972, notice in writing of a request for such an election has been given to the proper officer of the council of the district within which the **Parish Area** is situate by **TEN** electors for the **Parish Area**.

If a request for an election is not received by the above deadline then **Poulton with Fearnhead Parish Council** will co-opt a person to fill the vacancy as soon as practicable in accordance with the Local Elections (Parishes and Communities) Rules 1986.
